Privacy Policy

1. General

1.1. Stats.Video (<u>https://stats.video</u>) ("We", "Our", "Us") is committed to the protection of personal information provided by the users ("You", "Your", "User") Your agreement implies Your consent to the collection, retention and use of Your personal information in accordance with the terms of this Privacy Policy ("Privacy Policy").

1.2. We take the privacy of our Users seriously. We are committed to safeguarding the privacy of Our users while providing a personalized and valuable service.

1.3. When You use the Website, the Website may collect Your device number and other personal information. A high standard of security is maintained by Us for Our users. However, the transmission of information via the internet or telephone networks is not completely secure. While We do Our best to protect Your information, particularly with respect to protection of Your personal data, Stats.Video cannot ensure the security of Your data transmitted via the internet, telephone or any other networks.

2. Information Collected

- 2.1. Information You Provide Us: In the course of using the Website, we may ask you to provide us with certain information, including contact information, such as Your name or email address, unique identifiers, such as Your user id, or similar information.
- 2.2. We use YouTube API to get **public** information about channels and channel videos (including, but not limited to, number of views / likes / subscribers / comments, title, description, thumbnails, etc).
- 2.3. Site Usage Information: We may receive and store certain types of internet usage information whenever You visit the Website, such as Your click-stream data and your IP address. See "IP Addresses and Click Stream Data" section below.
- 2.4. If you want you can sign up for YouTube charts updates or any YouTube channel's stats update. You can opt out anytime by clicking the Unsubscribe link in every email. You will be forwarded to the Subscription management page where you can modify frequency of email notifications, or unsubscribe.

3. How Information may be collected

3.1. Registration: You may be asked to complete a registration form and provide personally identifiable information; you may also be asked to

choose a user ID and password in order to take advantage of certain features the Website may choose to offer, such as newsletters or contests. Participation in registration is voluntary and you will have the opportunity to decide whether or not to disclose information to the Website.

- 3.3. IP Addresses and Click-Stream Data: We may collect IP addresses and/or click-stream data. An IP address is a number associated with the service through which You access the Internet. Standing alone, Your IP address is not personally identifiable. At times, We also use IP addresses for purposes of system administration and to report aggregate information to Our advertisers and sponsors. We may combine this information with personally identifiable information. Click-stream data is information collected by Our computers when You request web pages from the Website. 4. Disclosure of Personal Information

4.1. 4.5. We use Our best efforts to use information in aggregate form (so that no individual User is identified) for the following purposes:

4.5.1. To build up marketing profiles;

4.5.2. To aid strategic development, data collection and business analytics;

4.5.3. To manage our relationship with advertisers and partners;

4.5.4. To audit usage of the Website and Our mobile application; and

4.5.5. To enhance user experience in relation to the Website ("collectively, "Permitted Use").

4.6. We reserve the right to disclose Personal Information if required to do so by law or if We believe that it is necessary to do so to protect and defend the rights, property or personal safety of Stats.Video, or Our Users.

5. Cookies

5.1. Whenever You access the Website, We may place "cookies" on Your hard drive for record-keeping purposes to enhance Your experience or sometimes to personalize Your experience. Cookies are small text files that are placed on Your computer's hard drive by the websites You visit. In all cases, use of information We collect is subject to the Privacy Policy in effect at the time such information is collected. You hereby acknowledge and agree that it is Your responsibility to review this Privacy Policy periodically and become aware of the modifications. If You disagree to any of the changes to the Privacy Policy, You shall refrain from using or accessing the Website. Your continued use of the Website, following the posting of the revised Policy shall indicate Your acceptance and acknowledgement of the changes and You will be bound by it.

9. Updates and Changes to Your Personal Information

You have a right to correct any errors in Your Personal Information available with Us. You may request Us in writing that We cease to use Your Personal Information. We will retain your information for as long as your account is active or as needed to provide you services. We will retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements. We will also remove on request, any or all data held by us as long as it is not in contravention with any applicable law at that time.
